RULES FOR PARTICIPATING IN THE DANCE COMPETITION

- 1. THE LAST DATE TO SUBMIT THE DUELY FILLED FORM IS 25TH SEPTEMBER 2024. NO FORM WILL BE ACCEPTED AFTER THIS DATE. Academy reserves the right to close registrations as soon as all slots are filled.
- 2. Prize distribution ceremony would be done on the same day. All Prizes will be given on the same date. No prizes will be given after the event.
- 3. For the Dance Competition normal stage, lights, and sound shall be provided to the performers.
- 4. Participants should be present at the VENUE at the **REPORTING TIME**. The reporting time will be given to participants **one week before the competition. LATE ENTRIES WILL NOT BE ACCEPTED.**
- The performance must be within the time limit mentioned and on recorded music only. NO LIVE MUSIC ALLOWED.
- 6. All the participants must MAIL their songs at- musicndanceacademy07@gmail.com by 20th September 2024. The delay may lead to cancellation of your participation.
- 7. All songs **MUST** be in **MP3** format. Any problem with the music for any reason ever will result in NO performance of the contestant. The organizer holds no responsibility in such situation. The contestant can keep a backup music with them to avoid any kind of inconvenience.
- 8. Parents/guardians of the participants are requested NOT to make any requests to the management for preferential treatment for their wards.
- 9. The decision of the Judges would be final. No queries shall be entertained for the same. If any participant, their parents, or any one accompanying them creates any kind of problem or misbehaves during the event this will lead to the participants disqualification from the competition.
- 10. The Organizer reserves the right to accept or reject the entry at any time without assigning any reason. Any kind of indiscipline or misbehaviour shall not be tolerated and lead to direct disqualification.

- 13. All performers in the group must fill separate forms with all the required details. NO FORM WILL BE ACCEPTED WITHOUT SIGNATURE AND PIC OF THE CONTESTANT
- 14. NO AMOUNT IS REFUNDABLE UNDER ANY SITUATION.
- 15. FOOD ITEMS ARE STRICTLY NOT ALLOWED INSIDE THE AUDITORIUM.
- 16. ALL ENTRIES ARE STRICTLY BY PASSES. NO ENTRY PASS FOR THE CONTESTANT. CONTESTANTS ENTRY WILL BE BY A COPY OF THE REGISTRATION FORM.
- 17. PEOPLE ACCOMPANYING THE PARTICIPANT WILL HAVE TO BUY THE ENTRY PASS. ANYONE ABOVE 5YRS OF AGE WILL BE ALLOWED ENTRY BY PASS ONLY. **SINGLE ENTRY ON ONE PASS**.
